

**2019 Disclosures and Financial Agreement**

**1. Insurance Disclosure**

I understand that the insurance provided by the Northern California Volleyball Association (NCVA) covers my daughter only as a participant during volleyball practice and during tournament play at tournament site gyms for the 2019 season. The NCVA insurance does not cover accidents that might occur to and from the practice and tournament sites.

**2. Fees Disclosures**

● **Non-Inclusions:**

- Food for tournaments, transportation and lodging costs
- For tournaments requiring overnight stay, all Players (team members) will divide the total cost for the team's lodging, transportation and parking costs incurred by the chaperones, and the cost for the Coach's lodging and parking. These costs will be divided equally by all Players, regardless of whether or not all Players participate in that tournament.
- Other miscellaneous items as agreed upon by the team

**3. Club Kalani Player Loyalty Program**

Returning players from the prior year season will receive a discount as specified by the program: Power = \$200; Premier = \$100; and Non-League = \$100. The discount will be applied towards the 4<sup>th</sup> and final payment, assuming the player's account is current and up to date.

**4. Full Financial Obligations – Parents and Players**

We, the undersigned, agree to participate under the Club Kalani Policies and Guidelines. We will satisfy our financial and volunteer obligations. We understand that there will be no refund unless there is an incident related to a season ending injury or a family crisis. If the incident occurs prior to February 15, 2019, then any refund will be pro-rated. There will be no refunds for incidents occurring after February 15, 2019.

**5. Payment Terms**

- I agree to pay a non-refundable Registration Fee of \$500.00 due at Registration on 11/13/2018
- Membership Fee will be paid in 4 Monthly Installments, with the first payment due on December 15, 2018, and the final balance due by March 15, 2019
  - Payment Schedule for each program and the minimum monthly installments are as follows:
    - Power League = \$550.00, Returning Player: Payments 1-3 = \$550, 4 (Final) = \$350.00
    - Premier League = \$425.00, Returning Player: Payments 1-3 = \$425.00, 4 (Final) = \$325.00
    - Non League = \$375.00, Returning Player: Payments 1-3 = \$375.00, 4 (Final) = \$275.00
    - Development = \$275.00
  - Failure to comply with the Payment Schedule:
    - Result in your daughter to be ineligible to attend practices and tournaments, until the balance is brought current
    - For payment extensions, contact our Club Administrator prior to February 15, 2019, or your daughter will be ineligible for the remainder of the season
